GRANT APPLICATION – 2011-2012

The Lebanon Educational Foundation provides funding for innovative educational programs & projects for which school funding is not available. To that end, we are pleased to invite you to participate in our grant process.

- APPLICATION DEADLINE:** March 1, 2012 4:00 p.m.  
Mail or bring completed application to the Foundation office at Hattie B. Stokes Elementary, 1005 Hendricks Drive or P. O. Box 47, Lebanon, Indiana 46052 or the Administration Center, 1810 N. Grant St.  
\*Inter-office mail will be accepted but must be received by 4:00 p.m. on the deadline day. Please keep delivery time in mind if you send your application via inter-office mail.
- ELIGIBILITY:** Projects must cover instructional enrichment.  
School funding must not be available for the project.  
No salaries will be eligible for funding.  
No funding will be available for snacks or party supplies.  
Field trips must have an educational component. Field trip fees should be above and beyond costs which parental financial support cannot pay.  
Minimal funds will be available for capital expenditures and equipment.  
March 1, 2012 funded projects must be completed by May 31, 2013. Grant usage extensions must be pre-approved in writing by LEF.
- FUNDING:** Grant requests may range up to \$2,500.00  
Notification of funding will take place 30 – 45 days after submitting the grant.  
Funds will be dispersed by the LCSC Administration Office upon receipt of the proper claim forms, receipts, invoices etc. and with an appropriation number which will be provided to the grant recipient at the time the grant is awarded.
- REPORTING:** A final report is due 30 days after project completion, and must include:
- A complete record of expenses;
  - A narrative describing project implementation, evaluation and results;
  - Any photos taken during the project.
- Any unused funds over \$1.00 must be returned to the Foundation.  
Failure to complete a final report on time will jeopardize future grant opportunities.
- PROMOTION AND MARKETING** If you receive funding from LEF you must agree to promote and publicize the Lebanon Educational Foundation's support of the grant. Promotion includes notifying LEF, parents and the media of opportunities to view and/or participate if applicable. Recipients must also agree to volunteer for one LEF event. (This included, but is not limited to serving on the grant committee, or the golf outing.) LEF must be notified 10 days prior to the grant being utilized. Contact LEF for additional details.
- JUDGING CRITERIA:** Number of students impacted by the proposal.  
Number of schools involved and the cost per student.  
Originality and creativity.  
Need for the program and projected educational value. (Please include any standards this project would cover)  
Will the school budget normally fund this project?
